EDITORIAL

The Light We Seek

In the ancient stones and quiet chambers of our Scottish Lodges, surrounded by symbols older than nations and truths deeper than oceans, we gather—not merely to perform ritual, but to engage in a quest that has shaped humanity since the dawn of consciousness: the pursuit of Light. The spirit of Freemasonry endures—not as a relic, but as a living, breathing force. It is in the warmth of clasped hands, in the solemnity of the ritual, and in the quiet humility of a Brother offering help where none was asked. Scottish Craft Masonry, with its unique heritage and broad influence, continues to be a light in a world sometimes dimmed by discord.

We gather in our Masonic Temples—not merely to perform ritual, but to engage in a quest that has shaped humanity since the dawn of consciousness: the pursuit of Light. Freemasonry, in all its complexity and tradition, does not promise us answers. Instead, it offers us tools—a square, a compass, a trowel—not to measure the world, but to shape ourselves. In an age where information floods us like a storm, wisdom remains the rarest of treasures. And it is here, in the silence between words spoken in the Lodge, that we begin to understand: Light is not something we find, but something we build within.

What is this Light? Some say it is truth. Others say it is virtue, justice, or divine understanding. Yet perhaps Light is not a thing, but a state—a clarity of being in which our actions align with principles, our hearts beat in harmony with humanity, and our minds are attuned to something greater than the self.

Among our enduring values, none shines brighter than charity. Not simply the giving of coin, but the giving of self—the willingness to step beyond comfort to ease the burden of another. It is this kind of charity that our Operative forebearers modelled, labouring together not merely to build cathedrals of stone, but communities of strength. In Scottish Lodges, where the traditions of the Craft are steeped in centuries of communal life, charity is not occasional—it is essential. We build funds, yes. But more importantly, we build relationships that bridge hardship with hope.

And yet, charity alone is not the full measure of our Craft. We are, in every Lodge, mentors. It is in the Scottish ritual—distinctive and rich—that one can see the layers of wisdom passed not in lectures, but in example. The Entered Apprentice watches the Fellowcraft, the Fellowcraft learns from the Master Mason, and all learn from the present and Past Masters who, though silent in office, speak volumes in presence.

Mentorship is not a programme; it is a pattern of life. Our Lodges are among the last places in society where young men sit beside elders—not in competition, but in communion. In a world that often rushes past reflection,

we offer the stillness of shared experience. We teach not only signs and words, but how to face adversity with dignity, how to lead with humility, and how to grow without pride. And we are all still learning.

What makes this possible is the principle that often receives too little applause but undergirds all we do: unity in diversity. The Scottish Craft, like our nation, has always been a tapestry woven of many colours and cultures. In the last issue of our Newsletter, we had communicated the news of a few of our temerarious brethren from Lodge K. R. Cama No. 1366 S.C. at Nagpur planning a masonic adventurous mission to Umling La, Ladakh - the highest motorable pass in India at 19024 feet (5798 meters) above sea level to create a record of sorts to commemorate the Spirit of Freemasonry through a symbolic meeting at the highest point in India

In a breath-taking display of Masonic adventurous resolve, Brethren from across India did convene on 24th June 2025 at Umling La after traversing from Nagpur by train via Ambala, Delhi, Manali, Sarchu/Jispa, Leh, Khardung La, Nubra valley, Turtuk, Shayong, Pangong lake, Hanle and finally reaching Umling La, the world's highest motorable road, to conduct a symbolic Masonic meeting amidst the stark beauty of Ladakh. This historic event is a tribute to the enduring spirit of Freemasonry, which transcends borders, climates, and even altitude.

Umling La, the world's highest motorable pass, situated near the Indo-China border in Ladakh, offers a panoramic yet stark terrain that symbolizes perseverance, brotherhood, and the pursuit of light—ideals that resonate deeply with Masonic principles. This historic Masonic meeting was convened not only to honour the geographic heights of India but also to spiritually elevate the fraternity. Due to the extreme altitude and military sensitivity of the region, careful coordination was essential like obtaining Permissions from the Border Roads Organisation (BRO) and local authorities. The meticulous but torturous labyrinthian planning also involved Brethren undergoing medical clearance, transportation of life-supporting gear, thermal gear, and communication devices.

In a breath-taking escapade symbolizing the ascension of the human spirit and the Mason's journey from the darkness of the valley to the light of truth. The bravura and virtuosity of these brave hearts was symbolic of a Toast to Universal Brotherhood and Peace and Symbolized the ascension of the human spirit and the Mason's journey from the darkness of the valley to the light of truth. The Silence of the Himalayas offered a moment of solemnity, where nature itself seemed to respect the sacredness of the gathering. The hoisting of the Tricolor and Masonic Banner hoisted alongside at the acme represented patriotism and fraternal unity.

The meeting at Umling La was a historic first for Indian Freemasonry, showcasing the fraternity's ability to adapt, endure, and hold true to its ideals in even the most inhospitable environments. This event reaffirmed the Brethren's commitment to light, learning, and universal brotherhood—at the very rooftop of India, notwithstanding the severe cold and thin air limiting the session and the Ritual paraphernalia being adapted for harsh environmental condition.

With true Masonic ethos, on 26th June 2025, our Brethren conducted a Charity drive at Mahabodhi Maitri Geriatic Home – Leh, where 40 sets of fully body thermals tops & lowers, woollen socks, woollen gloves, winter slippers, woollen caps were donated.

Bro. Jatinder Singh - District Grand Senior Warden presented the District Grand Lodge Rank certificates to W. Bro Mehernosh Mavalwala, Secretary of Lodge K. R. Cama as the District Grand Lodge Almoner and to R.W.M. Bro. Gp. Capt. Digvijay Mohbe as the District Grand Sword Bearer.

Fortunately, there were no major cataclysm and things went off as planned to a tee. We hope that the audacious and avant-garde spirit of our Bro. Mehernosh Mawalwala and Group Captain Digvijay Mohbe who both conceptualised the mission shall orchestrate future symbolic meetings at significant landmarks to strengthen bonds and highlight Freemasonry's relevance to both tradition and exploration.

The setting of the Masonic meeting added profound meaning to the occasion:

- The Great Heights echoed the Mason's quest for light, growth, and perfection
- The Silence of the Peaks fostered contemplation and unity
- The Indian Tricolor and the Masonic Banner flew together, symbolizing harmony between patriotism and fraternal duty
- Ritual paraphernalia had to be adapted for harsh environmental conditions

The Masonic meeting at Umling La stands as a historic and spiritual milestone. It was a tribute to the fortitude, unity, and eternal search for truth that define Freemasonry.

APPENDANT DEGREE OF ROYAL ARCH MARINERS

On Wednesday, 14th May 2025 Companions of Royal Arch Mariners' Lodge attached to Royal Arch Chapter Rising Star of Western India witnessed an impressive ceremony of the installation of Bro. P. Venkatraman as the Worshipful Commander Noah. It was a pleasure to see the participation of a motley number of brethren.

In Scottish Freemasonry, the Royal Ark Mariner (RAM) degree, also known as the Degree of Worshipful Commander Noah, is an appendant degree closely associated with the Mark Master Masons and is believed to have been originated in the mid eighteenth century. It is not part of the "Ancient and Accepted Scottish Rite", but rather an appendant degree administered under the Supreme Grand Royal Arch Chapter of Scotland.

It draws its symbolism and teachings from the biblical story of Noah and the Ark, focusing on themes such as faith, obedience, and salvation. typically conferred in a single ceremony. The presiding officer is called the Worshipful Commander Noah, symbolizing Noah himself and the narrative centres on Noah's preparation for the Flood, construction of the Ark, and his righteousness in the eyes of God. In this degree there is a heavy use of ark imagery, water, and the rainbow, representing deliverance and divine covenant.

The degree, typically conferred in a single ceremony, is highly symbolic, focusing on the values of moral conduct, obedience to divine law, and survival through righteousness. The Ark, animals, flood, and covenant with the rainbow are central elements of the degree and the candidate assumes the symbolic role of Noah's sons (Shem, Ham, or Japheth), being brought into the ark as a sign of trust and worthiness.

The regalia includes a rainbow-colored jewel or ribbon, symbolizing the covenant and divine promise and the officers wear aprons and collars distinctive to this degree. During the working of this degree, the brethren are beholden to its teachings of Obedience to divine instruction (Noah building the Ark without question), Salvation through faith and righteousness, Hope in adversity, as symbolized by the Ark surviving the flood and finally, the importance of moral conduct in achieving spiritual safety.

The key Scriptural Elements in this degree comprises of a narration when God commands Noah, a righteous man, to build an ark to preserve life during the coming flood. As a result, Noah, his three sons (Shem, Ham, and Japheth), and their families are spared. The rainbow becomes the symbol of the covenant between God and man.

The Theme of this degree dwells on Emphasising the virtues of faith, obedience, moral uprightness, and divine reward for righteousness. It symbolizes the journey through moral and spiritual storms, with the Ark representing salvation or the Lodge itself.

"PLASTIC-FREE LIVING" A SUSTAINABLE SHIFT FOR A HEALTHIER PLANET

The use of plastic as a medium of use in the various chores in our daily life, though convenient, has at the same time proved to be a hazard of mammoth proportions due to the non-biodegradable nature and a wildlife hazard. Besides, in its process of production, harmful chemical releases of a toxic nature are released and the fragments of microplastics contaminate water, soil, and even the food chain.

In the current times avoiding plastic becomes a significant step toward eco-friendliness because plastic pollution is one of the most pressing environmental issues today. Some of the measures that need to be implemented are advanced usage (preferably bulk purchases) of reusable containers like glass, stainless steel, or bamboo alternatives. Also recommended are using wax wraps, paper bags, cardboard containers, cloth covers, or glass

lids, carrying fabric tote or backpack. Further, Avoid disposable cutlery and straws and instead switching to bamboo or metal versions.

We are proud to note that Lodge Zoroaster No. 800 S.C. has taken a lead initiative in this direction by embarking on an ecological positive step at Freemasons' Hall Mumbai. As a first step, plastic bottles at the banquet are an absolute taboo and they insist on glass bottles instead. Besides, they are venturing on undertaking a movement for segregation and recycling all single use plastics generated by the users of this Premises.

The users include the Masonic bodies beholden to different Constitutions as well as the restaurant housed in our premises. As a precursory step to this initiative, plastic bins are being provided and the users are being educated by Lodge Zoroaster. The plastics collected shall be picked up by "Project Mumbai" a Charitable Organisation specializing in recycling of disposable plastic.

MEC NIHAL FONSEKA APPOINTED TO SLT BOARD

Veteran banker and MEC Nihal Fonseka of Chapter Dalhousie NO. 182 S.C. under Grand Chapter U.S.R.A.F.IC. has been appointed to the Board of Sri Lanka Telecom (SLT) as an Independent Non-Executive Director.

Fonseka is a retired banker and served as the Chief Executive Officer of DFCC Bank from 2000 until 2013. Prior to joining DFCC Bank, he was the Deputy Chief Executive of HSBC Sri Lanka. He was the Senior Independent Director of John Keells Holdings PLC, Sri Lanka's largest public listed conglomerate with a market capitalisation of over \$ 1 billion, for 10 years until June 2024.



He is a Member of the Governing Board and Monetary Policy Board of the Central Bank of Sri Lanka (CBSL) since July 2022, after having served as a Member of the Monetary Board of the CBSL from 2016 to 2020. Currently, he is also a Director and Chairman of the Group Audit Committee of Brandix Lanka Ltd., one of the largest apparel exporters in Sri Lanka supplying global brands, with manufacturing operations in five countries. He is also the Chairman of Phoenix Industries Ltd., and an Independent Director and Chairman of the Investment Committee of Phoenix Ventures Ltd. He was the President of the Sri Lanka National Advisory Council of the Chartered Institute of Securities and Investments, UK, from 2011 to 2021.

Fonseka was a past Chairman of the Colombo Stock Exchange and the Association of Development Financing Institutions in Asia and the Pacific (ADFIAP). He has also held non-executive public sector positions as a Director of the Employees' Trust Fund Board and as a Member of the Presidential Commission on Taxation (2009), National Procurement Commission, and the Strategic Enterprises Management Agency (SEMA).

He holds a BSc from the University of Ceylon, Colombo, and is a Fellow of the Institute of Financial Studies, (FIB), UK, and is an Honorary Fellow of the Chartered Institute of Securities and Investments, FCSI (Hon), UK.
